11/16/07 Frack Lovington Sand perforations w/ 488/0 lbs 20/40 sand carried by 522 bbls gel.

This well was subsequently put on pump test by running 2 7/8" tubing w/ seating nipple @ 3495' and running 3/4" rods. The pump was torn up by sand, shut down waiting to test premier and Penrose zones.
