BEPCO, L.P. respectfully requests the changes listed below be approved for the captioned well:

1) The well will be drilled utilizing a closed loop mud circulating system without a reserve pit being built or utilized. All water or mud used as drilling fluids will be cleaned and recycled or trucked to an approved disposal site. All drill cuttings will be collected and trucked to an approved disposal site.

2) A BOP equivalent to Diagram 2 will be nipped up on the surface casing head and tested to 1000 psig with the rig pump. A BOP equivalent to Diagram 1 will be nipped up on the intermediate casing and tested per the APD.

5 M CHOKE MANIFOLD EQUIPMENT-CONFIGURATION MAY VARY

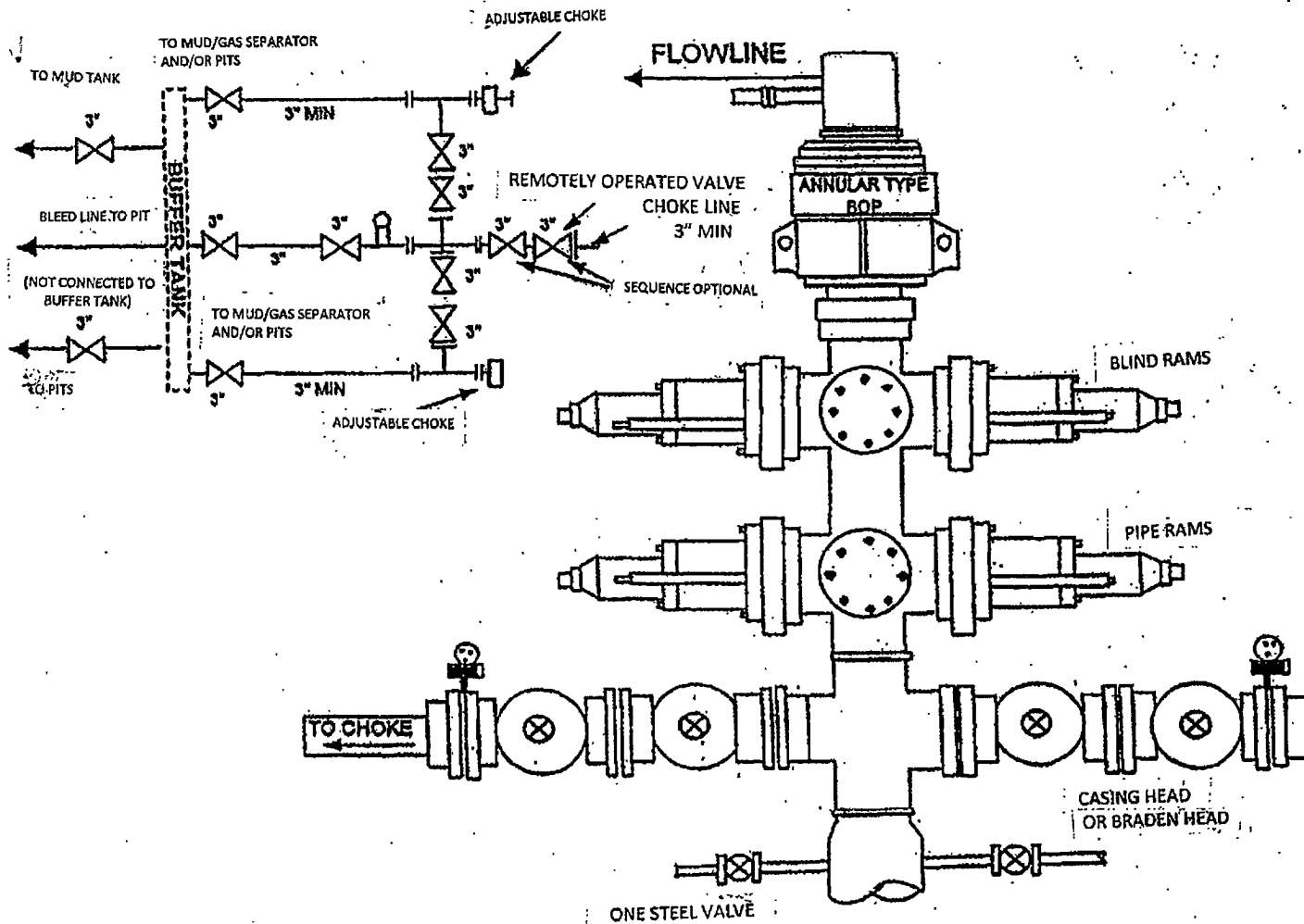

Conditions of Approval**

- 1. Based on the MASP that could occur prior to setting the intermediate casing (approximately 1600 psi using the heaviest mud for the surface hole) the BOP test is to be 2000 psi and a pressure test at that pressure must be done with a third party.**
