- 08.29.08 Pressure tested surface casing to 1000 psi for 30 minutes.
- 08.30.08 in 11" hole, ran 8 5/8" 24# J-55 LTC to 1258.' Cemented with Lead 250 sx Interfill C + 5% D44+ 10% D20 + .125 pps D130 + 2 pps D24 - (wt 11.9, Yield 2.46) and Tail 200 sx Class C + 2% S1 - (wt 14.8, yield 1.34). Circulated to surface. WOC 23 hrs.
- 08.31.08 Pressure tested intermediate casing to 1000 psi for 30 minutes.
