Water is piped to the Trigg Federal SWD located in Unit letter L, Section 7, T21S, R28E, Eddy County New Mexico. The Trigg Federal API No. is 30-015-25006. Salt water disposal is permitted under Administrative Order SWD-802 issued by the New Mexico Oil Conservation Division in June, 2001.
