11/26/08 Resumed drilling at 12:00 AM. TD 14-3/4" hole and set 11-3/4" 42# H-40 ST&C casing at 500'. Cemented with 100 sx Class "C" + 4% D20 + 2% S1 + 0.2% D46 (yld 1.98, wt 12.9). Tailed in with 200 sx Class "C" + 2% S1 (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 1400 psi for 30 min. WOC 23 hrs 20 min. Reduced hole to 11" and resumed drilling.

12/2/08 TD 11" hole and set 8-5/8" 24#, 32# J-55 ST&C casing at 3177'. Cemented with 725 sx Class "C" + 3.76#/sx D020 + 0.188#/sx D046 + 1.88#/sx S001 (yld 1.97, wt 12.9). Tailed in with 200 sx Class "C" + 0.94#/sx S001 (yld 1.33, wt 14.8). Cement circulated to surface. Tested casing to 1520 psi for 30 min. WOC 21 hrs 10 min. Reduced hole to 7-7/8" and resumed drilling.

12/5/08 Reached TD 7-7/8" hole at 4300'. Set 5-1/2" 15.5# J-55 LT&C casing at 4300'. Float collar at 4254'. Cemented with 235 sx Litecrete + 47#/sx D046 + 12,737#/sx D049 + 70.5#/sx D065 +
