11/7/2008: Circulate hole with 10# brine with 12.5# per barrel salt water gel. Spot 25 sack plug on CIBP. Perforate 4 squeeze holes at 450'. Pump 110 sack cement plug and circulate to surface. Well plugged and abandoned. Witnessed by Phil Hawkins.
