Spudded well on 3/4/09. Drilled 12-1/4" hole to 475'. Set 8-5/8" 24# J-55 csg @ 470'. Cmted w/350 sx (466 cf) cl "C" cmt w/2% CaCl2 & 1/4# C/F. Circ 113 sx cmt to pit. Witnessed by Darrel Carter w/BLM. On 3/5/09, pressure tested 8-5/8" csg to 500 psi for 30 min - OK.

Drilled 7-7/8" hole to TD3223' on 3/11/09 & ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 3212' w/PBTD @ 3168'. Cmted lead w/350 sx (623 cf) 35/65 POZ "C" cmt w/5% salt, 0.3% FL-200, & 1/4# super flake & tailed w/350 sx (462 cf) cl "C" w/0.3% FL-200 & 1/4# super flake. Circ 184 sx cmt to pit. Released drilling rig on 3/12/09. Plan to pressure test 5-1/2" csg during completion operations.
