Call the BLM with 24 hour notice before commencing operations.

RU safety equipment as needed. Pump 2% KCl water down tubing as needed to ND wellhead and install BOP. POOH with tubing and downhole equipment. Set 7" CIBP at 7532' and cap with 35' cement. Load hole with 2% KCl water with 1 gpt corrosion inhibitor. Pressure test casing to 500 psi and record with chart for 30 minutes. If casing fails pressure test, decide whether or not to look for holes or proceed with P&A.

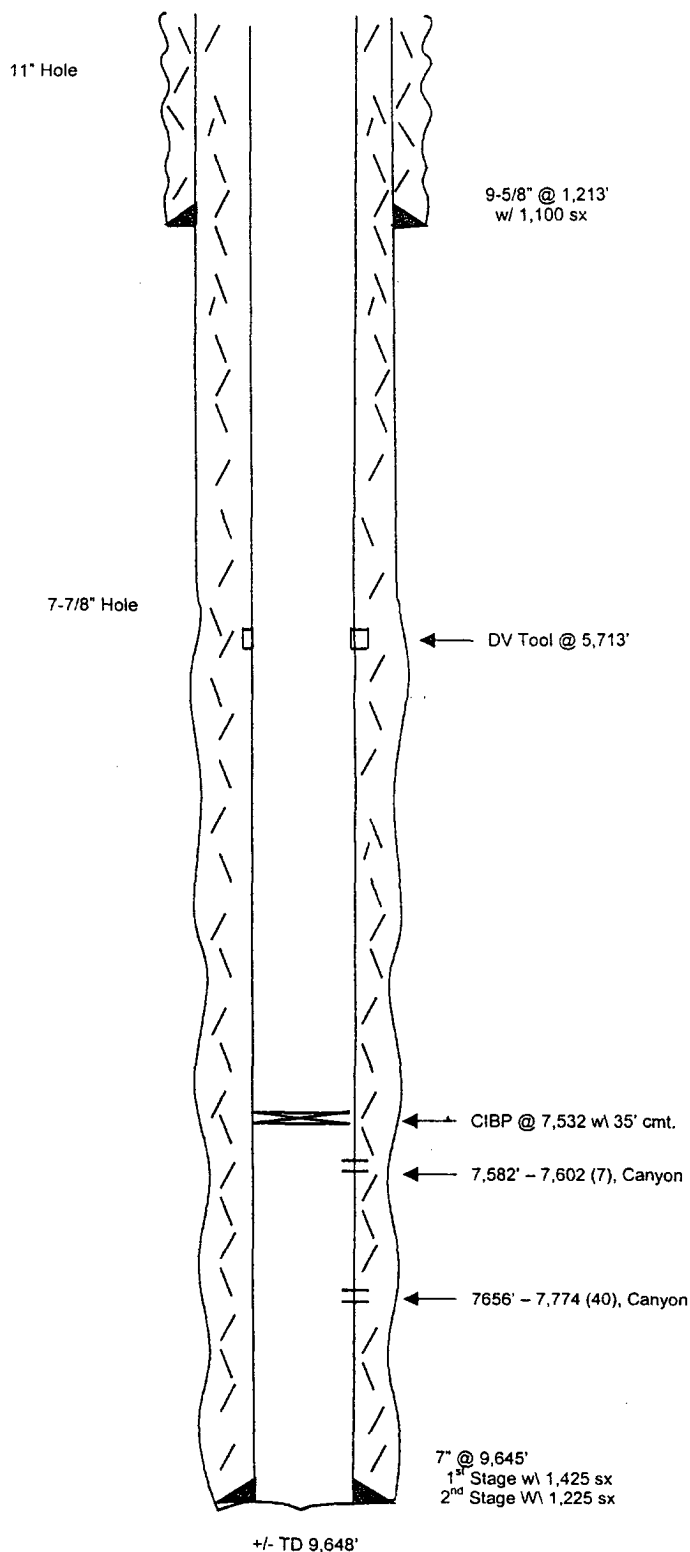
