The release was identified during the pit closure process when the 5 point composite sample was obtained from the excavated pit area two feet below the liner. The root cause of the release was a leaking liner.

Describe Area Affected and Cleanup Action Taken.*

The affected area is directly below the reserve pit. Lab results indicate elevated levels of chlorides. Excavation/remediation will continue with the contaminated material being transported to a division-approved disposal facility. Further soil analysis will be conducted to determine the progress of the remediation.
