05/08/09 Tagged plug @ 860'. Perf'd 5 1/2 csg. @ 400'. Could not pump into perfs. BLM ok'd to RIH w/ tbg to 450' and circulate 50 sx class C cement to surface. did so. Cut off well head and Weld on Dry hole Marker. cleaned location rigged down moved off.
