5/14/09 Tagged plug @ 815'. POH w/ tbg. Perf. csg. @ 400'. ND BOP. Put swedge in well head. Broke circulation. Sqz'd 110 sx class C cement down csg. and up back side to surface.. Cut off well head and weld on Dry Hole Marker. Rugged down and clean location.
