**Comments on Inspection:** Tank Battery for his well has had an unreported release. This is in violation of NMAC 19.15.2.8.


Please submit a proposal for repair and/or replace of Tank and for the remediation of produced fluid released to the OCD District 2 office no later than August 21, 2009.
