MIRU Mesa Well Service workover rig per verbal authorization from Bryan Arrant, NMOC, Artesia Office. ND Tree and NU 5M Hyd Double Ram BOP. Kill well w/ 2% KCL water. Release packer and TOH w/ tbg. MIRU Computalog electric line truck. Run 4.650" OD guage ring and junk basket to 11,200'. Set Alpha 10K CIBP at 11,175'. Dump bail 35' cement on top of CIBP. GIH w/ 3 3/8" OD TAG guns loaded 2 JSPF on 60 Deg phasing. Perforate 9687-9694' w/ 14 holes, 0.41" EHD. 32 gr charge.

TIH w/ 2 3/8" X 5.50" Arrowset 1X pkr w/ T2 on/off tool w/ 1.81" "F" profile nipple. Set packer at 9586' w/ 12K compression. ND BOP, NU Tree. Open up well and started flowing. Flow 100 mcf/d. RU BJ Services and acidize Wolfcamp perms 9687-94' w/ 1000 gal 20% NEFE + 14 Ball Sealers. Flow test well. 24 hr potential production test--310 mcf/d, 28 bbls condensate--54 gravity, & 0 water w/ 300 psi on 32/64 choke. Rig down and release workover rig. NEW PBTD--11,140'. NEW RESERVOIR---WOLFCAMP.
