Describe Cause of Problem and Remedial Action Taken.*

The flow line ruptured, the well was shut-in and a vacuum truck was called to the location.
The flow line was repaired. Free standing fluids were recovered.

Describe Area Affected and Cleanup Action Taken

The impacted area was located 10' north of the wellhead on location, the release flowed across the location and pooled in a material supply pit located next to the location. The weather at the time of the release was clear & dry. The soil in the area of the release is sandy loam overlaying caliches. The visibly impacted soil was excavated and then hauled to an NMOCD Solid waste disposal facility. Less impacted soil was excavated and then placed on a liner set on the location. Soil samples will be taken for analytical from the excavated area on location and the stockpiled soils. The soil samples taken will be submitted to a second party Lab. The soil samples will be analyzed for TPH using EPA method 8015M & B-TEX using EPA method 8020B.

When analytical results for a soil sample taken from the excavated area and the stockpiled soil reflect the TPH & B-TEX to be under the RRAL for the site, A final C-141 form will be submitted to NMOCD requesting closure for the release that occurred on 2/29/2009.

Depth to ground water - > 50', Wellhead protection area - > 1000', Distance to surface water body - > 1000' Site ranking score 0 points.
