09/03/09...MI & spud 11" hole. Ran 823' 8 5/8" 24# J55 ST&C csg. Cemented with 100 sks Thixad Class H w/additives. Mixed @ 14.6 #/g w/ 1.52 yd. Tail with 400 sks Class C w/additives. Mixed @ 14.8 /g w/1.34 yd. Plug down @ 9:00 pm 09/04/09. Did not circ cmt. Slow rate lift pressure @ 223# @ 2.5 BPM. WOC. Ran temp survey indicating TOC @ 112'. RIH with 1" pipe. Tag at 136'. Ran 1" pipe in 2 stages with 555 sks Thixad Class H with additives. Mixed @ 14.8 #/g w/ 1.34 yd. Circ 10 sks to pit. WOC 18 hrs. At 5:30 pm 09/05/09 tested BOPE and casing to 1500# for 30 minutes, held OK. Drilled out with 7 7/8" bit.

09/10/09 TD'ed 7 7/8" hole @ 3420'. Ran 3450' 4 1/2" 11.6# J55 LT&C csg. Cemented w/100 sks Thixad Class H with additives. Mixed @ 14.6 /g w/1.52 yd. Followed w/300 sks BJ Lite Class C (50:50:10) w/additives. Mixed @ 15.5 /g w/2.71 yd. Tail with 300 sks Class C with additives. Mixed @ 14.8 /g w/1.33 yd. Plug down @ 2:15 am 09/10/09. Circ 170 sks cement to pit. At 2:15 am on 09/10/09, tested csg to 1500# for 30 mins, held OK. Set wellhead slips w/30k.
