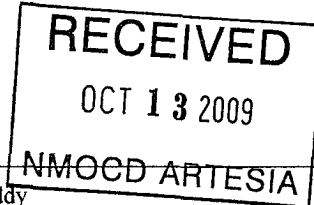

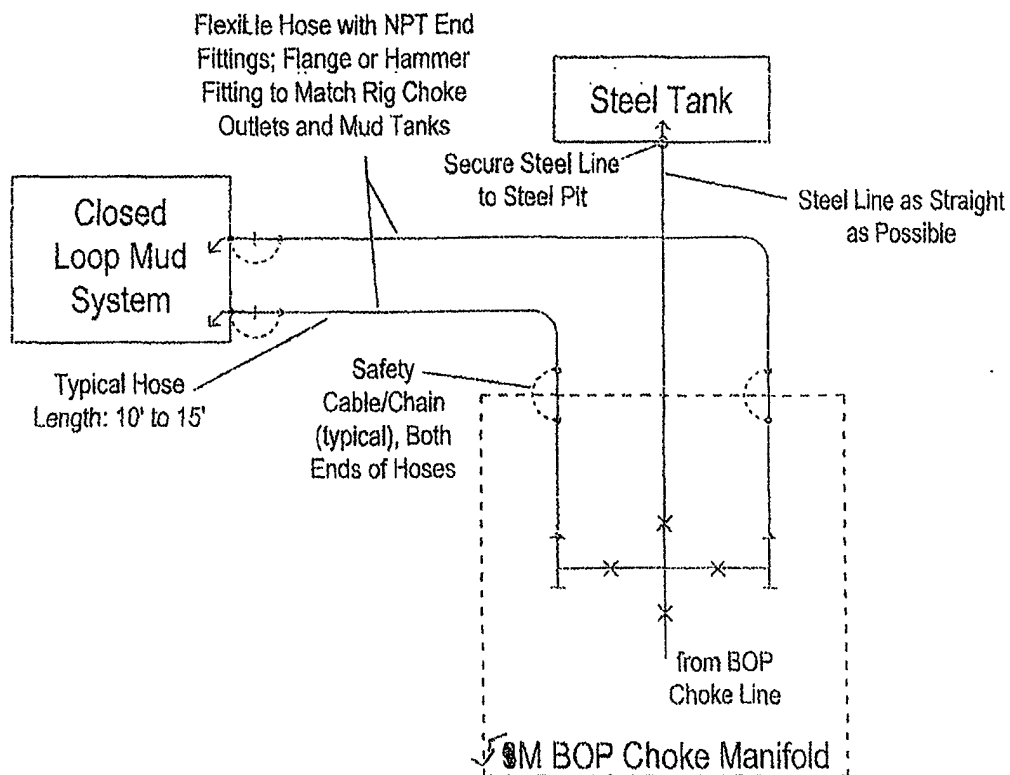

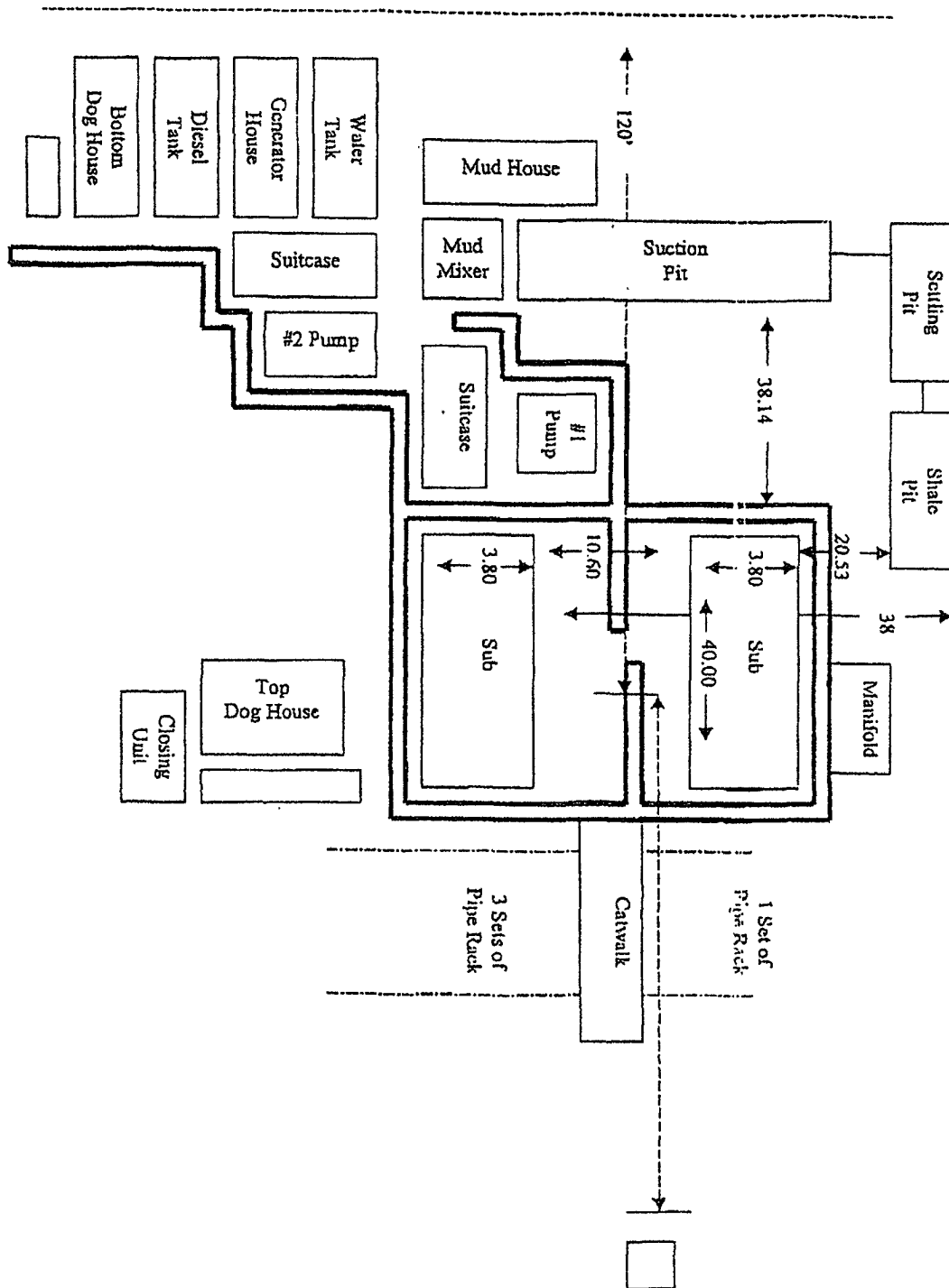

- 2 -- CRI Bins with track system
- 2 -- 500 bbl. frac tanks for fresh water
- 2 -- 500 bbl. frac tanks for brine water

Operation and Maintenance

- Closed Loop equipment will be inspected daily by each tour and any necessary maintenance performed
- Any leak in system will be repaired and/or contained immediately
