Forest Oil is requesting TA status on the above mentioned well.

The Lea D 1 is to be utilized for future beneficial purposes. A field study is in progress which will determine the purpose of the wellbore. Current options include conversion to injection to support offset producing wells or conversion to a producing well. The zones targeted for recompleat are the Grayburg and Seven Rivers. It is anticipated that product pricing will allow for an economic conversion or recompleat. The anticipated date of this work is unknown at this time, but the study will continue into the year 2010. Richard Inge of NM OCD witnessed and retained the charts of an MIT test on 8-21-2009, pressured up to 500 lbs. for 30 minutes, CIBP@3218'.
