- Remove any remaining equipment: pumping unit, flowlines, meter run, electrical equipment, etc.
- Remove and dispose of any contamination to BP-approved disposal site.
- Cap old pit area.
- Use dozer to flip site in order to bury caliche and return suitable soil to surface, or strip and remove caliche, depending on soil conditions; e.g. no top soil, too rocky. If applicable, an earthen berm will be placed on the end of the access road to deter vehicular traffic.
- Rip location and contour it back into the surrounding area to promote proper drainage and re-vegetation.
- Seed location with BLM-approved seed mixture.
