FOR THE PAST YEAR, NO WATER HAS BEEN PRODUCED FROM THE MORROW ZONE IN THIS WELL IF ANY WATER IS PRODUCED IT WILL BE STORED ON LOCATION IN A 300 BBL TANK UNTIL SUFFICIENT VOLUMES ARE COLLECTED TO REPRESENT A FULL TANK TRUCK LOAD. AT THAT TIME OIL THAT MAY HAVE COLLECTED ON TOP OF THE WATER, IF ANY, WILL BE PULLED OFF AND TRANSFERRED TO THE OIL TANK THEN THE SALT WATER WILL BE HAULED BY A CANTU TRANSPORTATION SERVICES TRUCK TO A COMMERCIAL SWD WELL FOR DISPOSAL. CURRENTLY THE DISPOSAL USED BY CANTU IS THE BIG EDDY FED #100 SWD, LOCATED IN NW/4 - SW/4 SEC 8 - T21S - R28E, EDDY COUNTY, NM (PERMIT #461) CONSIDERING THE NEGLIGIBLE VOLUMES OF WATER PRODUCED, THERE IS NO SPECIFIC TIME SCHEDULE FOR WATER HAULING.
