Operating and Maintenance Plan:

BC Operating will use all above-ground steel pits for fluid and cuttings while drilling. If any tank develops a leak, it will be repaired and/or contained immediately. The OCD will be notified within 48 hours of the remediation process start. Rig crews will monitor the tanks at all times to make sure all equipment is operating correctly.

Closure Plan:

While drilling all cuttings and fluids associated with drilling will be hauled off and disposed of via Controlled Recovery Incorporated facilities Permit R-9166.
