BOPCO, L.P. respectfully requests permission to recomplete the subject wellbore in the Wolfcamp formation as follows:

- 1. Plug back Morrow with CIBP set @ 12,100' + 35' Class H cmt on top. Perforate Wolfcamp (10,180'-10,192').
- 2. Acidize perfs with 3,500 gals 15% HCl acid.
- 3 Evaluate inflow performance of well, fracture stimulate with 97,500# 20/40 Carboprop.
- 4. Set CIBP (@ 10,000') above Wolfcamp (10,180'-10,192') & perforate Wolfcamp (9,802'-9,816').
- 5 Acidize perfs with 1500 gals 15% HCl.
- 6. Evaluate inflow performance of well, fracture stimulate with 97,500# 20/40 Carboprop.
- 7. After 30 days, drill out CIBP (10,000') & produce from both zones.

RE: Plug back and Recomplete NOI – Conditions of Approval

There is to be no surface disturbance beyond the existing pad. A closed loop system is to be used. H2S monitoring and protection equipment is to be on site.

Before perforating the Wolfcamp, properly Plug back above the Morrow. In addition to the CIBP you have proposed, a 220' plug of Class H cement (minimum 25 sx) from 11970'-11750'.

Submit subsequent report and completion report once work is completed.

A commercial well determination will need to be submitted after production has been established for at least six months.
