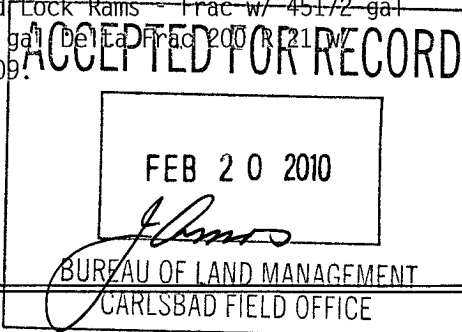

Close BOP and Lock Rams - Frac w/ 45172 gal Water Frac GR 11 followed by 4000 gal 7-1/2% HCl Acid followed by 290209 gal Delta Frac 200 R 21 w/ 503350# sand, RD Halliburton RU Arc, flow back and test from 11/9-11/18/09.
