01/07/2010: Hauled 1004 cu ft caliche from location to BEU #70 road and Indian Flats main road. (Samples were taken from the west side of the location. The samples' chloride levels were below 250 ppm max allowed by state of New Mexico.) 12,250 square feet was reclaimed from site and area was graded & contoured to blend with the surrounding topography. Cleared site will be re-seeded in the spring.

Site is ready for interim reclamation inspection.
