Did not circ cmt. Slow rate lift pressure @ 295# @ 2 BPM. WOC. Ran temp survey indication TOC @ 30'. RIH with 1" pipe. Tag at 114'. Ran 1" pipe in 15 stages with 445 sks Class C w/CACI2. Mixed @ 14.8 #/g w/1.34 yd, and 350 sks Thixad H w/additives. Mixed @ 14.6 #/g w/1.52 yd. Tag 1" pipe @ 57'. Cement to surface w/24 yds Redi-mix. WOC 18 hrs. 04/29/10 tested BOPE & casing to 1250# for 30 minutes, held OK. Drilled out with 11" bit.
