RUPU. Set CICR @ 3252' and squeezed perforations 3460'-70' w/ 200 sx Class "C" containing 2% CaCl₂, 0.25% R-38 (s.w. 14.8 ppg, yield 1.32 ft³/sx) and displaced with 8.5 bfw to 300 psi and SD 15". Drilled cement out and circulated well clean. Tested casing to 500 psi w/ 410 psi loss in 10" and held 90 psi for additional 20". Spotted 250 gals 7-1/2% NEFE acid @ 4090'. Perforated Cherry Canyon Delaware at 4000' - 4090' w/ 3-1/8" csg gun w/ 1 JSPF, 0 42" EHD, 60° phasing, total 91 holes. Acidized Delaware perfs w/ 3000 gals 7-1/2% NEFE acid and 180 - 1.3 sg ball sealers. RIW w/ 4-1/2" CIBP and tbg to 3943' and set CIBP to TA Well. POW and LD down tbg. ND BOP and NUWH with tbg flange w/ 2" valve and pressure gauge. Installed bull plugs on casing valves and RDPU and released rig.
