

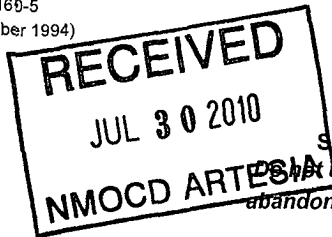

Cimarex proposes to drill the surface hole with a 16" bit instead of the permitted 14 3/4" bit. Cement with Lead 200 sx Class C + 0.4% D-20 + 1% Salt + 0.125# D-130 + 4# D-42 (wt 12.9, yld 1.99) and Tail 200 sx Class C + 1% S-1 + D-42 + 0.125# D-130 (wt 14.8, yld 1.34). TOC 0.
