Yates Petroleum Corporation respectfully requests permission to reduce the production hole to 8 1/2" instead of 7 7/8".  
An 8 3/4" hole will still be drilled to 8,662' MD (8,390' TVD). If 7" casing is not set then hole will be reduced to 8 1/2" where 5 1/2" casing will be set and cemented as follows:  
Stage I from 7800'-12805': cement w/1660sx Pecos Valley Lite (YLD 1.41 WT 13) TOC=7800'  
Stage II from 5700'-7800': cement w/750sx Pecos Valley Lite (YLD 1.41 WT 13) TOC=5700'  
Stage III from 3900'-5700': lead w/300sx Lite Crete (YLD 2.66 WT 9.9), tail w/100sx Pecos Valley Lite (YLD 1.41 WT 13) TOC=

If 7" casing is warranted by hole conditions, then contingency plan will be used as permitted.
