8/9/10 – RIH with GR/JB to 7720'. Set a CIBP at 7716'. Tested plug to 1000 psi, held Ok. Dumped 35' cement on top of CIBP.

8/10/10 – Circulated hole with salt gel and brine. Spotted a 100' cement plug across DV tool from 6262'-6362'. Spotted a 30 sx cement plug across Wolfcamp top from 5447'-5607'. Spotted a 25 sx cement plug across Bone Spring from 3347'-3497'. Spotted a 25 sx cement plug across Glorieta from 2128'-2248'. Spotted a 150 sx cement plug across casing shoe from 1055'-1205'.

8/11/10 – Tagged plug at 1037'. Pumped a 25 sx cement plug at 100'. Circulated 10 sx to pit. ND BOP.
