Drilled out stage collar at 9716' and drilled out float shoe and shoe joint to 12260'. Circulate hole with 2% KCL water. Ran GR-CNL log and perforated Lower Morrow 12200'-12210' w/4 jsp. Ran 2 3/8" tubing and packer and set at 12121'. Swab tubing dry. No show of gas or water. Acidized with 1000 gals 7 1/2% acid. Swab tubing dry. No show of gas. Set a CIBP @ 12180'. Dump bailed 35' of cement on top. Prepare to test Middle Morrow.
