Upon completion of evaluations, should results indicate, the well will be plugged and abandoned.

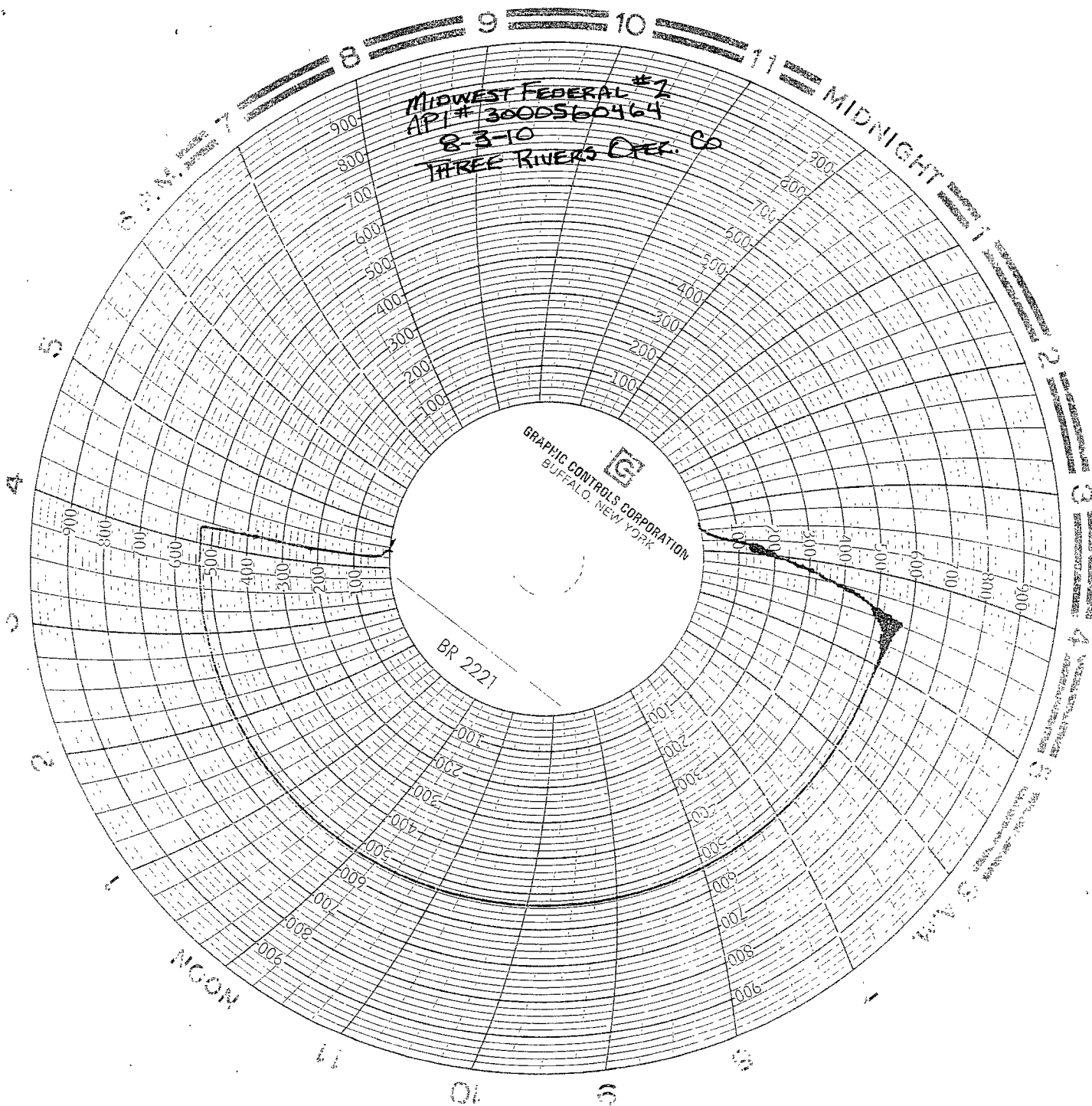
