7-6-10 RIH w/OS on 2-7/8" WS to 704' & got over fish. PU to 40,000# w/no movement. RU Gray WL. Tried to run FP, but could not get past OS. PU spud bars & RIH. Rls OS and POH. 6' piece of cable in OS. RBIH w/OS & caught fish. Ran spud bars. Tagged @ 832'. RIH w/FP to 3510'. 44% free @ 3480. PU to 3420', strtd getting FP & pipe came free. RD WL.

7-7-10 Pld & LD 79 jts badly pitted tbg & sub equip. Stood back 11 stds. Ran 4-3/4" bit on 2-7/8" WS.

7-8-10 Ran bit, tagged @ 3598'. POH w/50 stds tbg. Dropped 4 jts & bit in hole. RBIH w/tbg. Screwed onto fish. Pld & LD bit.

7-9-10 RIH w/4-3/4" bit & DCs on 2-7/8" tbg. Tagged @ 3590'. P/300 bbls wtr and did not get circulation. Found bit plugged. POH to DCs and bit unplugged. POH. RBIH w/bit & DCs. Est some circ w/5 bbls gone. Fluid started coming up around cellar.

7-12-10 Ran RBP & pkr on 2-7/8" tbg. Set RBP @ 3359', pkr @ 3227'. Tstd RBP to 1000 psi - OK. Tstd csg: 3359' to 482' good; 482-400 can pmp into leak .8 BPM @ 450 psi; 400-60' can pmp into leak 2 BPM @ 0 psi; 60' to surface have small leak off. Found hole in bell nipple on WH. Pld pkr.

7-13-10 ND BOP & WH. Welded another bell nipple on 5-1/2" csg. NU BOP & WH. RIH w/2-7/8" tbg to 505'. RU Rising Star. P/cmt dn 2-7/8" tbg & circ back up 5-1/2 & 8-5/8" annulus'. Did not come up around 8-5/8" csg. POH w/2-7/8 tbg. ND BOP & WH. NU collar & csg swedge. RU on 5-1/2 csg & p/200 sx @ .5 BPM 120 psi. Started coming up around 8-5/8" csg. RD Rising Star.

7-14/16-10 ND csg swedge, NU WH, BOP. PU 4-3/4" blade bit & DCs. DOC surface to 501'. Fell out. Circ hole clean. (continued page 2)
