JAM Oil respectfully request your approval for off lease storage and commingling. Attached is a map Green=shows existing flowlines and tank batteries on the lease. ~~Red= shows proposed flowlines. Blue= shows existing line~~ that will be used to transport all oil and H2O from the Mohawk, Dekalb & Leonard leases to the Mary Ann Cannon Facility. This well makes approximately 2 BOPD-.03 BWPD. Well test will be conducted monthly by producing each well for a 24 hr. period into a portable tank calculating the volume by color cut and shake out. Doing this and multiplying by the number of days produced each month. All oil produced from same zone and equal gravity so we see no effect on reduced royalties. One of the main reasons for this proposal is to help minimize the problems associated with this low gravity crude (heavy bottoms, high corrosion on the lifting equipment down hole and storage facilities). I am sure everyone involved is aware of the sporadic history over the past years, this proposal will help eliminate the long wait to fill a tank to marketable levels. Royalty Rates: Mary ann Cannon .75%, Dekalb .764, Leonard .74, Mohawk .76.

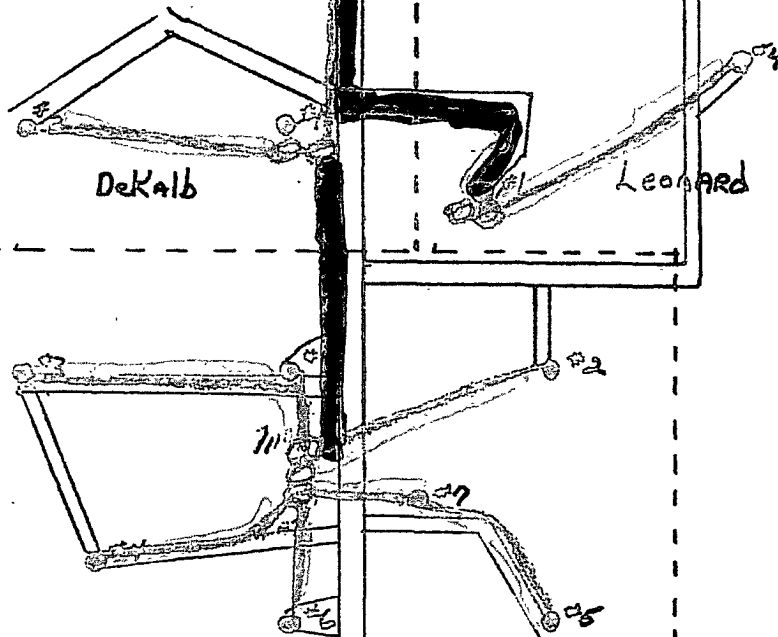

Conditions Of Approval**

1. This agency will be notified of any change in your sales method or location of the sales meter.
2. This agency shall be notified of any spill or discharge as required by NTL-3A.
3. This agency reserves the right to modify or rescind approval whenever it determines continued use of the approved method may adversely affect the surface or subsurface environments.
4. This approval is subject to like approval by the New Mexico Oil Conservation Division.
5. Additional wells and/or leases require additional commingling approvals.
6. Contact the BLM Roswell Field Office at least 24 hours prior to the commencing any monthly well test.
