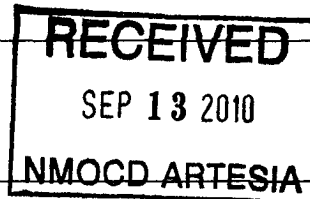

Describe Cause of Problem and Remedial Action Taken.\*

Battery was vandalized (valve was removed from the flow line to heater). Visually impacted soil was excavated and taken to CRI. Site was completely delineated in accordance with guidelines set forth by Sherry Bonham of NMOC D.

Describe Area Affected and Cleanup Action Taken.\*

Approximately 1500 cubic yards were excavated in the area surrounding the release point. The contaminated soil was taken to Lea Land LLC. Clean backfill was then brought in from Lea Land. The excavated area was backfilled and contoured to original location dimensions.
