

9/22/10 – NU BOP. Set a CIBP at 2130'.

9/27/10 – Circulated 35 bbls salt bring gel. Spotted a 25 sx Class "C" cement plug from 1762'-2133'. Spotted 30 sx Class "C" cement at 1174' across intermediate shoe. WOC. Tagged intermediate top at 600', good. Perforated surface casing shoe at 343'. Pumped down 4-1/2" casing, pumped 40 bbls. No returns up the 8-5/8" casing.

9/28/10 – Spotted 25 sx Class "C" cement. Displaced to 240' down 4-1/2" casing. WOC. Tagged shoe plug at 230'. Perforated at 200'. Pumped down 4-1/2" casing. Break circulation up 8-5/8" casing. Pumped 34 sx Class "C" cement to surface.

9/29/10 – Dug up cellar and cut off wellhead. Installed dry hole marker as per NMOCD. Covered cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
