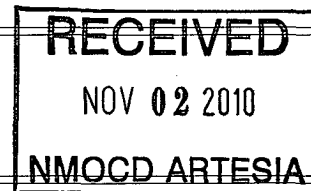

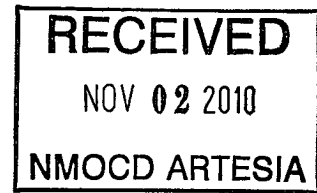

On behalf of BOPCO, L.P., Sport Environmental Services is providing the enclosed NMOCD Closed-Loop System Closure Report for BOPCO, L.P.'s North Indian Flats "24" Federal, Well #10 location.

The site closure consisted of removing visual signs of contaminated soil from the location and restoring the impacted area with reclaimed caliche. Approximately 12 cubic yards of visually impacted soil was excavated and disposed of offsite at the NMOCD permitted and approved facility, Controlled Recovery Inc. (Permit #R-9166). In addition, approximately 12 cubic yards of reclaimed caliche from the edge of location was used to fill in low spots and smooth out the location.

The Bureau of Land Management interim reclamation will be performed prior to the deadline. The location will be assessed to determine if the pad location can be reduced. If we can effectively operate with a reduced footprint, seeding will occur during the next growing season for optimal growth. BLM Seed Mixture #3 will be applied using the broadcast method. When broadcasting the seed, the pounds per acre will be doubled. As required by NMAC 19.15.17.13(I)(2), successful reclamation is considered to be 70% re-growth of the native perennial vegetative cover (un-impacted by overgrazing, fire or other intrusion damaging to native vegetation) consisting of at least three native plant species, including at least one grass, but not including noxious weeds, and maintain that cover through two successive growing seasons. During the two growing seasons, that prove viability, there will be no artificial irrigation of the vegetation. Repeat seeding or planting will occur, until required vegetation coverage is successfully achieved. Evaluation of growth will not be made before completion of at least one full growing season after seeding. Photographs of existing vegetation were taken prior to constructing the drilling pit location, as a tool to confirm re-growth of 70% native vegetative coverage.
