9/22/10 – NU BOP. TOOH with tubing. Set a 7" CIBP at 7658'. Loaded hole. Tested to 500 psi. Tagged CIBP. Spotted 30 sx Class "H" Neat cement. WOC.

9/23/10 – Perforated at 1130'. Pressured to 1500 psi. Spotted 40 sx cement at 1194'. WOC. Tagged at 955'. Perforated at 150' and circulated out 9-5/8" casing. Pumped 45 sx and circulated, casing is full. ND BOP.

10/5/10 – Dug out and cut off wellhead. Installed dry hole marker. Filled cellar and cut off anchors. Cleaned location. **WELL IS PLUGGED AND ABANDONED.**
