Cimarex will begin reclamation of the pad and access road on or about 2 September 2010 or as soon as archeological clearance has been secured from the BLM, as follows: (1) Reclaim the upgraded two-track road access from the Mesa State Com No. 1 (SE/4-31-15S-28E) to the Foran 30 Fed. Com. No. 1, continuing onto the Julia 30 Fed. Com. No. 1 (E/2-30-15S-28E) returning it to a primitive two-track for access to BLM's Range Study No. 454. This road requires two different seed mixes. The Loamy SD-3 seed mix shall be applied south of the pipeline crossing of the pad access road (approx. 1/3 of road). The Shallow SD-3/Very Shallow CP-4 seed mix is to be applied north of the pipeline crossing of the pad access road (approx. 2/3 of road). This mix shall also be applied to the reclaimed pad area. (2) The pit area shall be capped per the Pecos District pit capping policy. Soil samples were taken from the pit (NW/2 & SE/2) and selected areas on the pad. Since the pad and pit area are built on top of the narrow, historic two-track, an archeological survey shall be conducted in an expanded area so that adequate room will be available to comply with the District's pit policy. (3) The meter run of Gas Line NMNM06734 shall be removed prior to reclamation of the pad commences per BLM. (4) Cimarex shall comply with Onshore Order No. 1 XII B, which states that the extended grace period for completing reclamation ends in this case, 26 September 2010. (5) Final Abandonment Notice (FAN): The FAN is herewith submitted as a part of this Sundry and should be implemented when required actions have been accomplished as designated within the NWO. Cimarex, therefore, notifies the BLM that when surface reclamation has been successfully established, the location is ready for final inspection by the Authorized Officer and release of its bond is requested.

Please submit a Notice Of Intent (NOI)

for reclamation of these facilities.

Reclamation should include actions based on sampling data. A NOI with an separate attached reclamation plan is acceptable.
