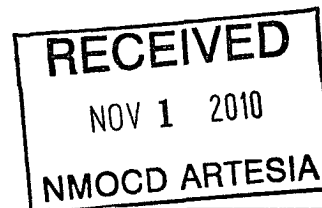

Existing Grayburg production intervals: 2041'-2047', 2147'-2172', & 2182'-2184'

1. Pull out of hole with existing rods, pump and tubing
2. Clean out well to TD
3. Perforate new production interval in Grayburg: 2125'-2128', 2224'-2227', 2236'-2239', 2287'-2323', & 2332'-2345'
4. Acidize perforations with \pm 9600 gals KCl acid (75 gals/ft)
5. Flow back and clean up well
6. Run in hole with new 2-3/8" tubing, rods and pump
7. Restore well to production and test
