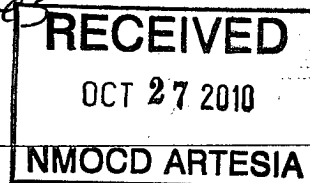
13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recomple horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports must be filed within 30 days following completion of the involved operations. If the operation results in a multiple completion or recompletion in a new interval, a Form 3160-4 must be filed once testing has been completed. Final Abandonment Notices must be filed only after all requirements, including reclamation, have been completed and the operator has determined that the site is ready for final inspection.)

Devon Energy Production Company L. P. respectfully requests to set the surface casing using an Ashton Oilfield Services rig. The rig plat is attached. This rig will be used only to set the surface casing and will leave the location once the surface casing has been run and cemented. Another rig will drill the remainder of the wellbore. The reasons for using the smaller rig to set surface are: rig availability and economics.

The BLM will be contacted 24 hours prior to commencing drilling operations. The surface casing will be run and cemented back to surface as per the approved APD. The well will be secured with a flanged wellhead that will have a flanged cap secured on top of the wellhead. Another rig will be on location to drill the remainder of the wellbore within 60 days after the Ashton rig has left the location.

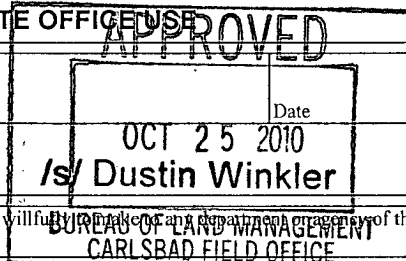
