10/14/10 – Set a 7" CIBP at 7600'. Loaded and tested casing to 500 psi. Tagged CIBP. Circulated hole with salt gel. Spotted 30 sx Class "H" Neat cement on top of CIBP. Calc TOC at 7440'. Spotted 65 sx Class "C" Neat cement at 6050'. Calc TOC at 5662'. Spotted 30 sx Class "C" Neat cement at 3848'. Calc TOC at 3669'. Spotted 30 sx Class "C" Neat cement at 2262'. Calc TOC at 2083'. Spotted 35 sx Class "C" Neat cement at 1174'. WOC.

10/15/10 – Tagged plug at 980'. Spotted 33 sx Class "C" Neat cement from 150' up to surface. ND BOP. Topped out casing with cement.

10/29/10 – Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar and cut anchors. Cleaned location. **WELL IS PLUGGED AND ABANDONED.**
