Spotted 55 sx Class "C" Neat cement at 5842'. Calc TOC at 5503'. Spotted 35 sx Class "C" Neat cement at 3810'. Calc TOC at 3595'. Spotted 35 sx Class "C" Neat cement at 2349'. Calc TOC at 2134'. Spotted 35 sx Class "C" Neat cement at 1214'. WOC.
