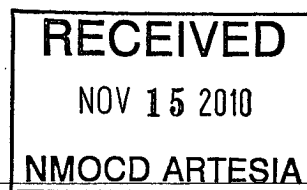

RIH & perf @ 10,895' - 10,899', 10,967' - 10,971' & 10,982' - 10,986'; (3SPF) 36 holes. POH WL. RIH w/WL entry guide, 2.25" R nipple, 8' tbg sub, 2 7/8" x 7" arrow set 1x pkr w/carbide slips & tbg. Ld csg w/2% KCL & tstd pkr to 1000 psi - held good. ND BOP & tree up well. Swab. MU tree savor & BJ, acidize upper Morrow lime from 10, 899' - 10,986' w/2,500 gals 15% HCL acid & 8,500 gal 15% retarded acid dropping 30 bll slrs - 3 stages @ 4900 psi @ 10 bpm. Swab. Open well, flw bck, swab. Turn well over to production.

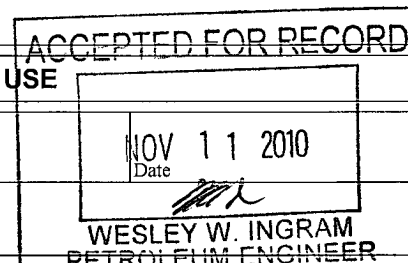
