10/20/10 NU BOP. RIH with GR/JB. Set a 7" CIBP at 7550'. Loaded and tested casing to 500 psi. Circulated hole with salt gel. Spotted 30 sx Class "H" Neat cement at 7550'. Calc TOC at 7385'.

10/21/10 Spotted 50 sx Class "C" Neat cement at 5525'. Calc TOC at 5218'. Spotted 25 sx Class "C" Neat cement at 2238'. Calc TOC at 2084'. Perforated 4 holes at 1140'. Pressured to 600 psi. Spotted 45 sx Class "C" Neat cement with 2% CaCl at 1200'. WOC. Tagged at 938'. Perforated 4 holes at 150'. Circulated out 9-5/8" x 7" casing, pumped 53 sx Class "C" Neat cement. Circulated to surface out 9-5/8" x 7" casing. ND BOP.

11/2/10 Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar and cut anchors. Cleaned location. **WELL IS PLUGGED AND ABANDONED.**
