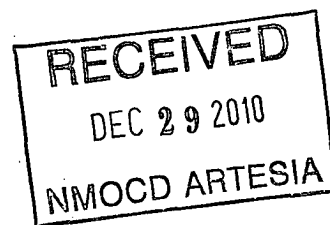

MI Republic Backhoe Services. Grader ripped south and east side of location. Hauled 868 cu.yds caliche to various locations and for road repair leading to the PLU #248 (BLM requested). After caliche removed, addressed erosion problems on west side loction. Ripped and countoured reclaimed area. Met w/ BLM, Justin Frye, okayed to procede w/seeding. EZ Roustabouts seeded area w/BLM #3 seed as requested.
