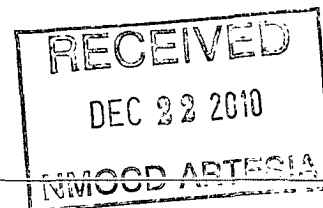

PDU 208 had perfs added in the Delaware A and B sands. Removed production equipment. RIH w/ bit clean out to 4529' (PBTD). Acidize existing perfs 4198-4236' w/ 1700 gals 15% NEFE HCL and 300 gals Xylene. Set RBP @ 4172'. Spot 500 gals 15% NEFE HCL. Perf Delaware A and B 4000-4003' (3 holes), 4014-4017 (3 holes), 4057-4067' (10 holes), 4129-4134' (5 holes). Acidize new perfs w/ 1050 gals 15% NEFE HCL. Frac w/ 26,460 gals 25# XL gel and 54,203# 20/40 SLC. Remove RBP clean down to 4529' (PBTD). Ran after frac GR. No treatment in upper perfs. Acidize 4000-4017' w/ 1500 gals 15% NEFE HCL. TIH w/ 135 jts. 2 3/8" J55 tbg. Set TAC @ 3976'. RIH w/ production equipment. Place well back on production.
