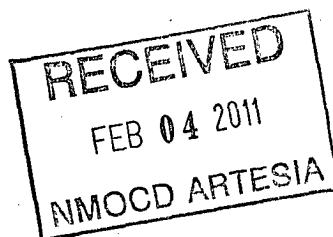

Dusty,

The BLM is in concurrence with OCD authorization. Provide like notification to myself prior to start and liner installation. Side samples will be needed to validate side walls are down to OCD closure limits. Upon completion of backfill the access road is to be returned to a condition as the adjacent landscape. Remove caliche, restoring the native soils and contour and seeded with BLM #2 seed mix. Place a fence across the access to keep vehicular traffic off reclamation. Greetings,

The remediation proposal submitted to the NMOCD District 2 Office for the release as listed above is approved with the following stipulations/conditions:

- Notify the District 2 office 48 hours prior to commencement of remedial activities.
- Notify the District 2 office 48 hours prior to installation of the liner.
- In the event further sampling operations are required, notify the District 2 office 48 hours prior to obtaining samples.
- Due to the elevated contaminant levels that existed throughout the affected area at 6 feet bgs, as indicated on the 3/29/10 sampling data sheet, OCD would request the target goal for excavation depth be a minimum of 8 feet bgs.
- Excavated material is to be disposed at a NMOCD approved disposal facility.
- The liner is to be installed on a smooth surface, free of any protuberances that may cause damage and/or failure of the liner.
- No portion of the liner may be closer than 4 feet to the natural surface grade.
- Like approval by BLM as may be applicable.

Be advised that this approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, this approval does not relieve the operator of responsibility for compliance with any other Federal, State, local laws and/or regulations.
