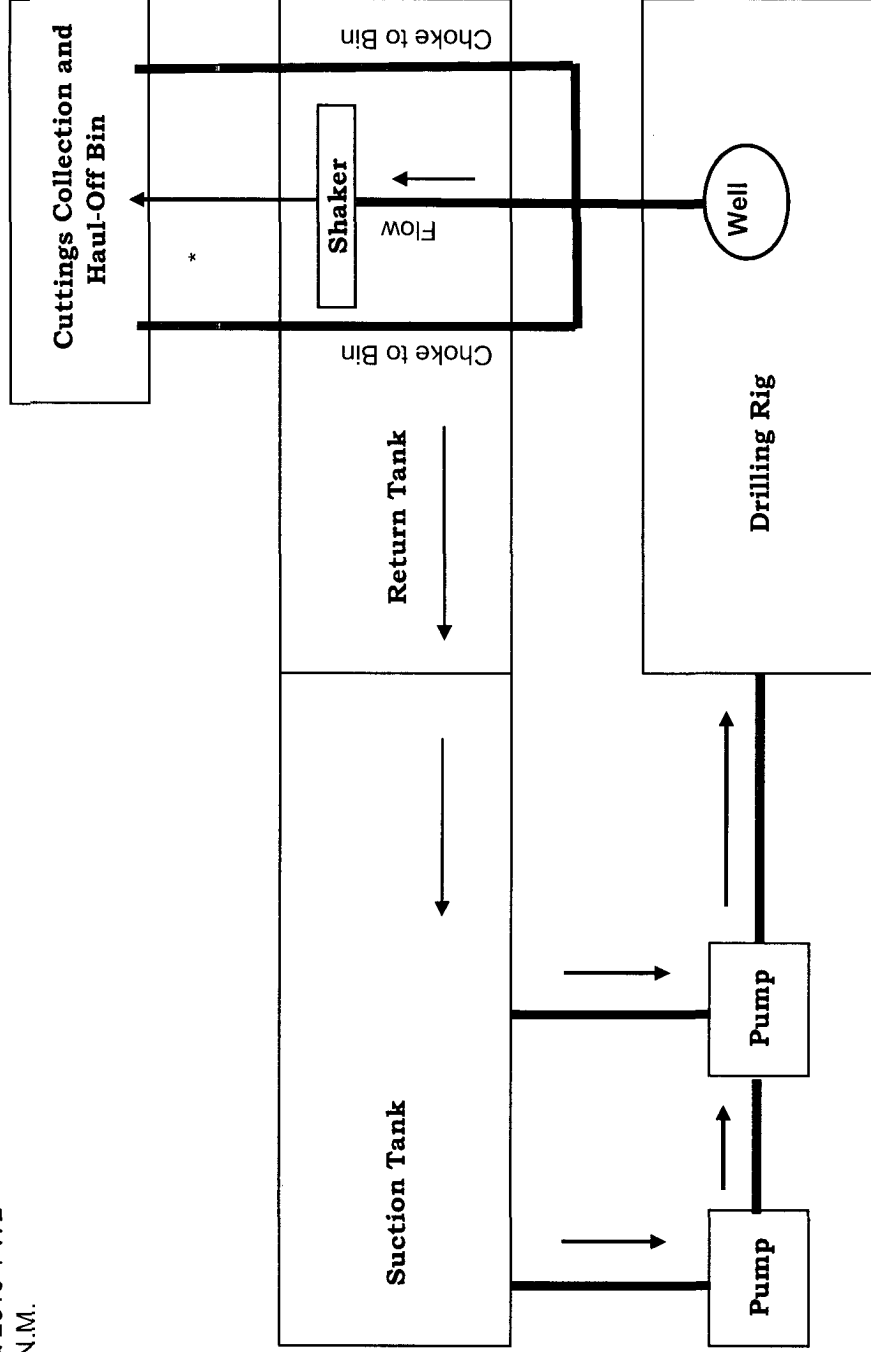

Choke Manifold Schematic for Closed Loop System

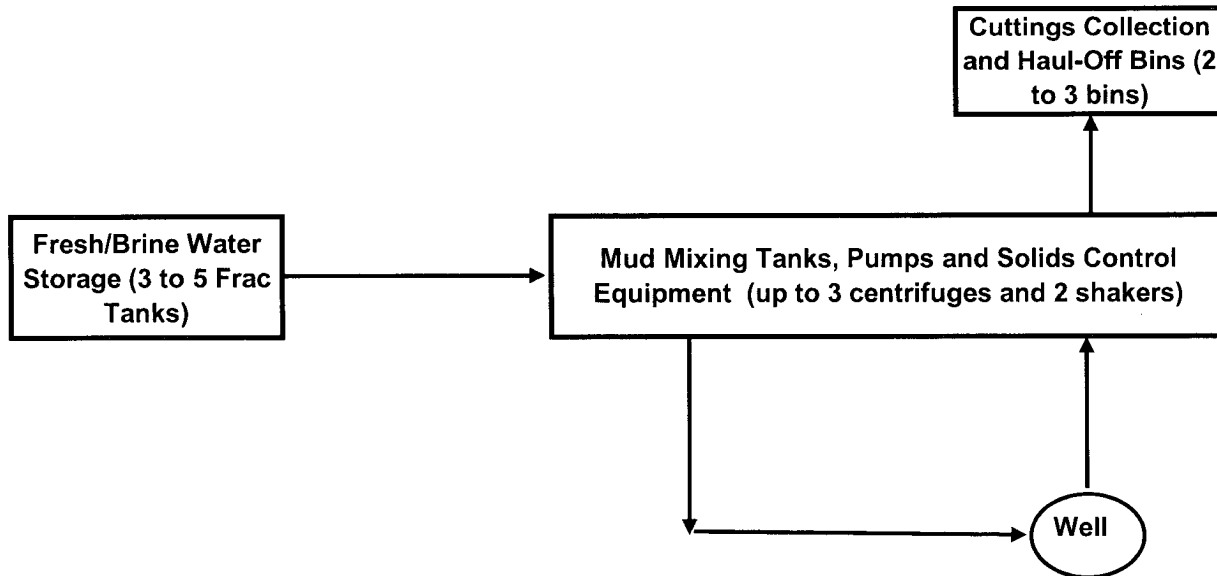

Operating and Maintenance Plan:

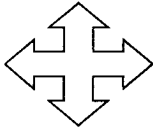

Closure Plan:

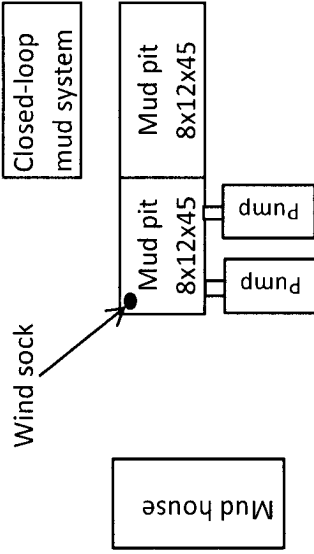

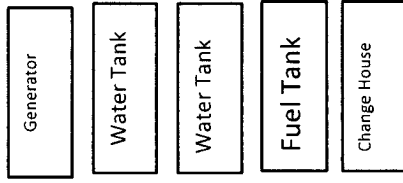
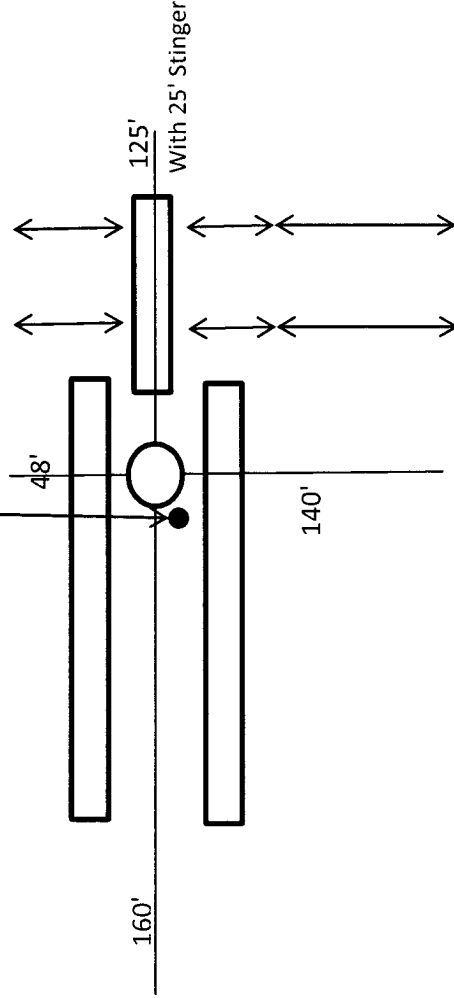
