BOPCO, L. P. respectfully wishes to report upgrades to the Poker Lake Unit Delaware "C" battery located at the Poker Lake Unit #184.

These upgrades will be done in an effort to be proactive in the prevention of spills involving containments. Due to the high volumes of fluid that this battery sustains there is a inherently higher risk for a spill.

As part of the battery upgrades piping modifications are to be done to allow improved visibility of flowlines, making them more accessible. Dirt work will be done, removing any lingering contaminants in preparation for the impermeable containment. The tanks will also be cleaned and coated internally and externally with a modified ploymer. An impermeable containment constructed from a two-component modified polymer elastomeric lining material will be retrofitted to assure containment of any future contaminants.
