Drill 8-3/4" hole to 8350' w/cut br mud system, wt 8.7-9.3, vis 28, set 7" casing & cement to surface. A DV tool will be set @ +/-7000'.

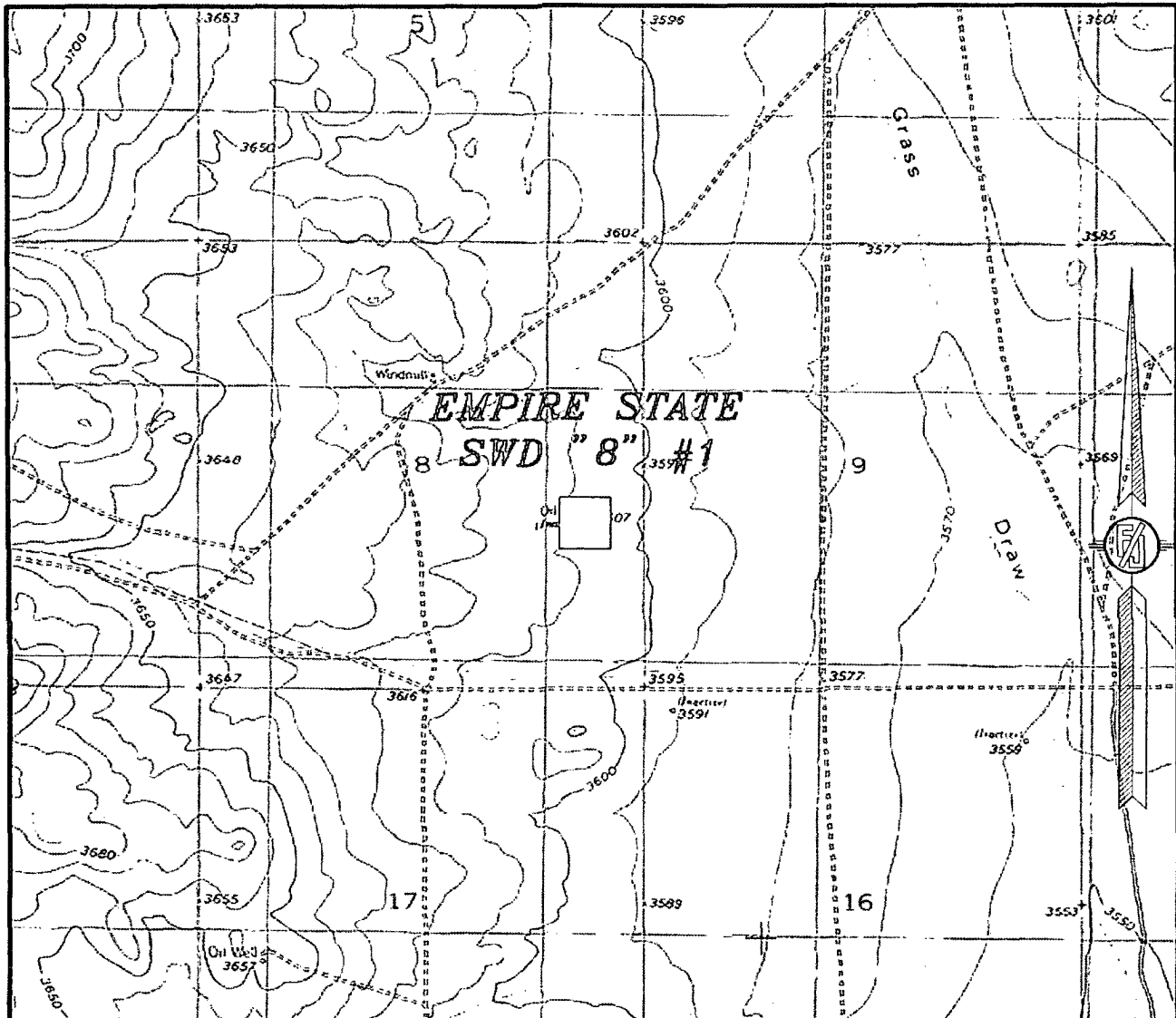

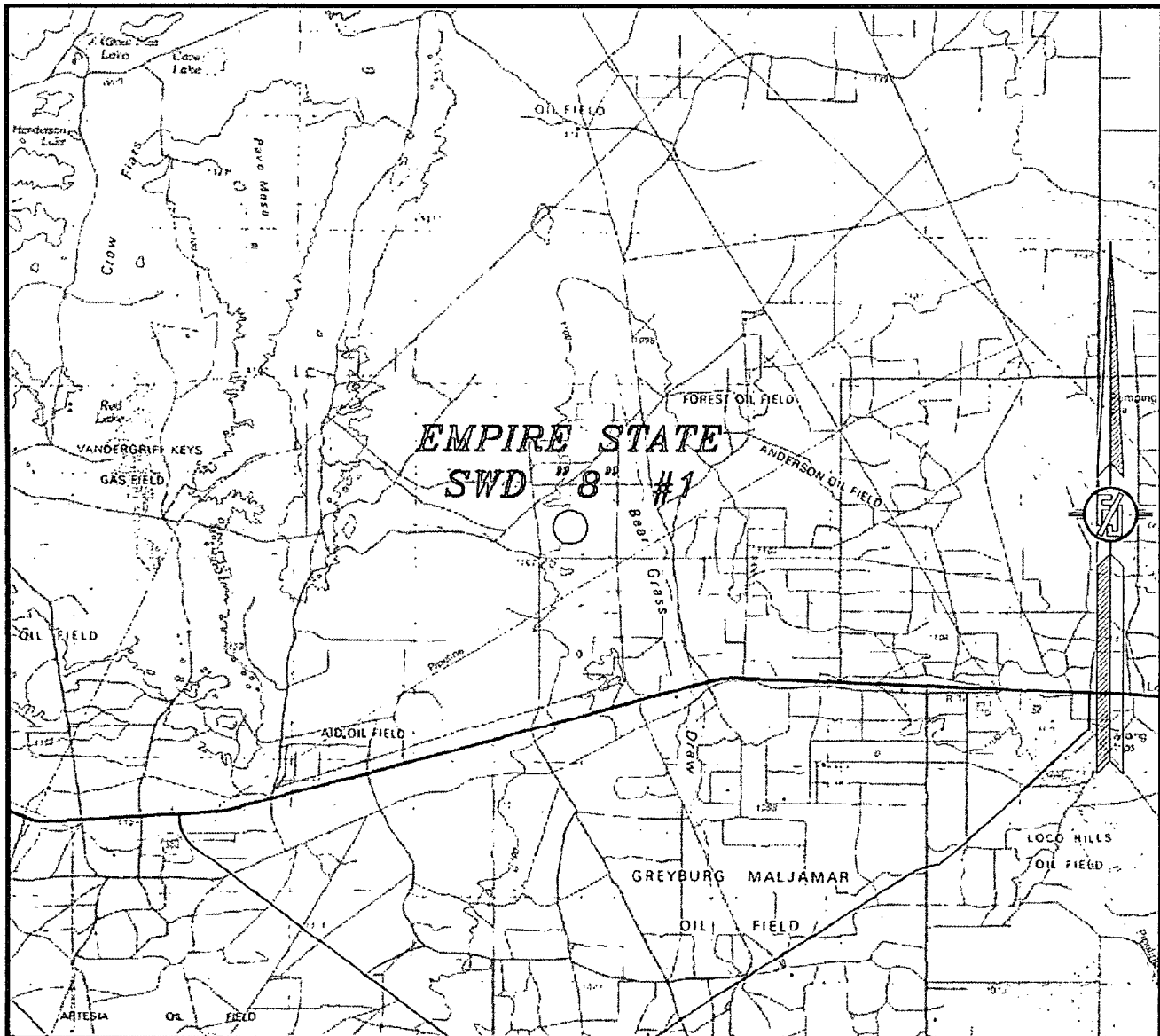

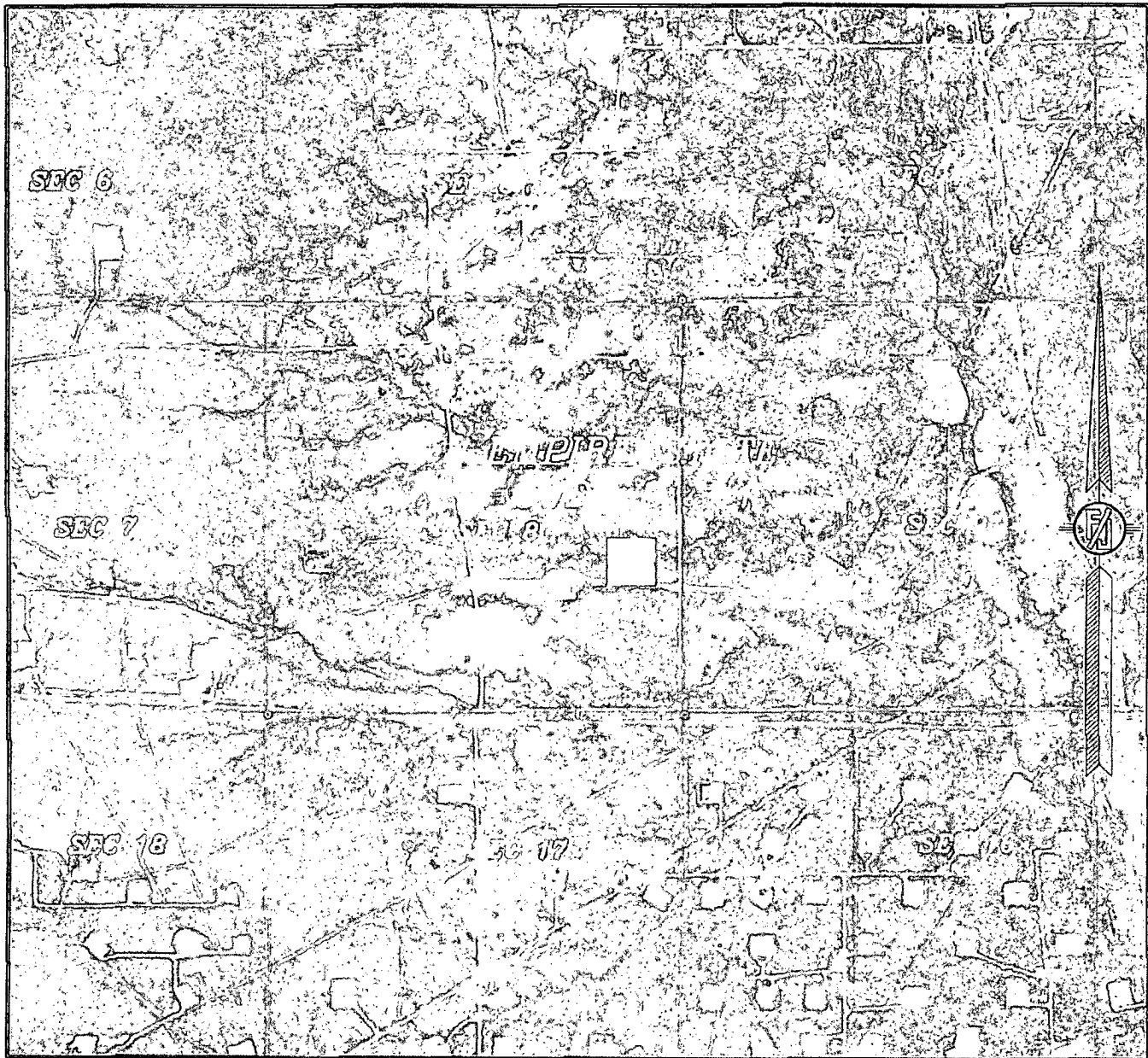
