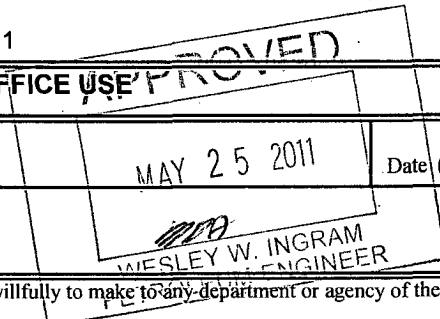

- 1. Bridge plug must be set 50-100' above perforations.**
- 2. Surface disturbance beyond the originally approved pad must have prior approval.**
- 3. Closed loop system required.**
- 4. A minimum of a 2M BOP is required and must be tested prior to performing operations.**
- 5. Subsequent sundry required.**
- 6. Work to be completed in 90 days.**
